 - Property tax/license has increased by 68%
- Summer volunteer application 5 new applicants
- Capital improvements
 - o All departments are creating lists for improvements
 - Need to get bids/quotes for improvements needed

MEMBERSHIP OPEN FORUM

- Communicating decisions made/pertinent information

- Communicate increases in insurance/utilities/taxes to general ownership
 - o Inflation is 25.2% over past 7 years
 - KOA Jackson, MN/Sioux Falls, SD comparable to Cutty's
 - \$67/night (Jackson, MN)
 - Promote monthly dues payments
 - Cutty's Des Moines dues are much higher
- Wifi questions regarding discussion on fiber (2 year estimate for this in our area)
 - Need to be cognizant of cost
 - Need to have a maintenance contract and replacement plan
 - Present a flyer with information regarding hot spot pricing
- Publish in an email the costs of the website since 2015 so owners are aware
- Consider offering a BOGO (buy 2 nights, get 1 free) for camping
- Parking stay within your campsite
- Electric vehicles are being plugged into the pedestal
 - o Charge a fee
- E-bikes and scooters need to adhere to 10 mph rule

SUGGESTION BOX

- Pool cleaning is this being vacuumed?
- Enforce hot tub rules
- Plungers/drain stoppers in shelter house, clogged toilets in shelter houses
- Towel rental \$1, can this be changed
- Replace paddleboats
 - These were discontinued secondary to insurance costs (per Ken Woelber)
- Change sign above member services to "Owner Services"
 - We are owners of the resort (evidence by deed) and members of Cutty's of Okoboji Resort Club
